Submitted in accordance with section 34B(3) of the *Prevention of Cruelty to Animals Act 1979 (NSW)*

As per the requirement of Animal Welfare League NSW (AWL NSW) as an approved charitable organisation under Section 34B of the Prevention to Cruelty to Animals Act 1979, I am writing to report to the Minister for Agriculture, of the exercise of powers by AWL NSW Inspectors under the Act for the twelve-month period ending 30 June 2025.

Listed below is information obtained from statistics held by AWL NSW Inspectors for the period 1 July 2024 to 30 June 2025.

(1) Information pursuant to clause 41(1) of the *Prevention of Cruelty to Animals Regulation 2025 (NSW)*:

(a) complaints received, and investigations undertaken, about the treatment of animals:

Between 1 July 2024 and 30 June 2025, AWL NSW lodged a total of 3104 complaints alleging cruelty to animals' contrary to the Prevention of Cruelty to Animals Act 1979 (NSW) (NSW) (**Act**), the *Prevention of Cruelty to Animals Regulation 2012 (NSW)* and/or the *Prevention of Cruelty to Animals Regulation 2025 (NSW)* (**Regulation**). These complaints often involved more than one animal and multiple breaches of POCTA were often attached to a single cruelty report. A breakdown of the type of complaint can be found below.

From 3104 complaints received, 3548 POCTAA breaches were investigated

(b) animals seized or taken possession of under the Act

Between 1 July 2024 and 30 June 2025, AWL NSW seized or took possession of 421 animals under the Act.

(c) a statement of the number of persons cautioned by officers of the organisations:

During the reporting period, AWL NSW officers issued 215 official cautions.

(d) a statement of the number of notices issued by officers of the organisation under Section 24N of the Act:

During the reporting period, AWL NSW officers issued 85 written directions.

(e) proceedings for offences instituted:

Between 1 July 2024 and 30 June 2025, AWL NSW commenced 7 prosecutions.

(f) the organisation's officers and the training provided for the officers:

As of 30 June 2025, the AWL NSW Inspectorate employs nine (9) Authorised Officers under the provisions of Part 2A of the Act.

Two inspectors are awaiting delegation of authority. All officers are employed on a full-time basis except for one officer who is contracted on a part-time roster.

(g) complaints about the organisation or the organisation's officers:

AWL NSW received 3 complaints during the reporting period. Please refer to table (j).

(2) Information pursuant to clause 41(2) of the *Prevention of Cruelty to Animals Regulation 2025* (NSW):

(a) a statement of the number of, and a summary of the substance of, complaints relating to animal cruelty or mistreatment received by the organisation during the reporting period for the report:

AWL NSW inspectorate operates 5 days per week. AWL NSW investigated 3104 cruelty complaints in the reporting period. The investigation of these complaints involved 3104 initial inspections and a further estimated 1262 rechecks. It is important to note there may be a slight margin of inaccuracy with rechecks as previous monthly reports are unattainable with staff changes and previous inconsistencies with reporting revisits on our database.

Rechecks were generally conducted by Inspectors to assess compliance with either written or verbal directions.

AWL NSW conducted an additional 456 routine inspections, some of which eventuated into cruelty investigations / non-compliance revisits. Our Sheltermate system does not have the capacity to record specific data to identify the number of those dispatch jobs that developed into investigations.

(b) a statement of the number of visits or investigations made by the organisation's officers as a result of the complaints during the reporting period for the report:

AWL NSW investigated 3104 cruelty complaints in the reporting period. The investigation of these complaints involved 3104 initial inspections and a further estimated 1262 rechecks.

(c) a statement of the number of visits or investigations made by officers of the organisation that were unrelated to those complaints (such as routine inspections of abattoirs, veterinary practices, pet shops or saleyards):

AWL NSW's Sheltermate database does not have the capacity to distinguish between cruelty complaints and 'routine' (proactive) inspections conducted on animal trades under the provisions of section 24G of the Act. Data is captured separately to record the number of 'routine' inspections conducted by the AWL NSW Inspectorate. A summary of the 456 'routine' inspections conducted during 2024/2025 is tabled below.

In addition to cruelty investigations and routine inspections, AWL NSW officers attended jobs lodged under general dispatch requests, assisted other Officers in Charge, attended ambulance requests where required and/ or assisted with animal control issues if available to do so and deemed appropriate.

Below is a table to reflect general dispatch jobs and those relating to animal control. Unfortunately, our Sheltermate database does not allow all Inspector assist jobs to be recorded for accurate figures.

AWL NSW employs one (1) ambulance officer who operates under our inspectorate department. Our ambulance officer not only responds to injured and / or sick animals but assists our inspectors with transporting animals that have been surrendered through our inspectorate back to our shelter in Kemps Creek.

The ambulance officer attended a total of 339 new jobs including assisting inspectors, shelter or our Branches. Below is a table to reflect the number of ambulance jobs lodged but does not include rechecks or those jobs assisting.

During the reporting period, AWL NSW officers issued 215 official cautions.

During the reporting period, AWL NSW officers issued 85 written directions.

Between 1 July 2024 and 30 June 2025, AWL NSW seized or took possession of 421 animals under the Act. Though the exact number of days cannot be accurately calculated, most of the inspector animals in care were in care for a minimum of 40 days. At the time of this report (September 2025), 9 inspector animals were still under the care of AWL NSW.

During 1 July 2024 and 30 June 2025, AWL NSW issued 31 Penalty Infringement Notices.

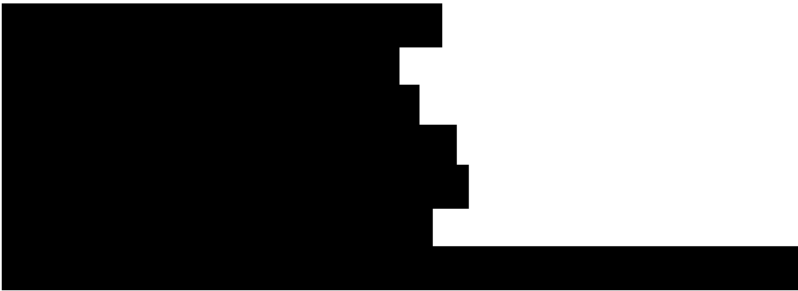

As of 30 June 2025, AWL NSW had a total of 9 authorised officers. These 9 officers are holders of a prescribed authority under the provisions of Part 2A of the Act, issued with the approval of the Minister for Agriculture. Inspectors [REDACTED] was employed in September 2024 and [REDACTED] was employed January 2025. Inspector [REDACTED] replaced [REDACTED] who resigned. Additionally, two Inspectors were recruited in March 2025, Inspector [REDACTED] In May 2025, Inspector [REDACTED] was employed and is awaiting her delegation of authority.

Complaint	A complaint was received from a POI regarding an Inspector requiring them to seek veterinary treatment for their dog. The Inspector stated they would follow up to check compliance. The POI complained that the Inspector should not need to reattend the premises.
Outcome	The Inspectors had followed all AWL NSW Policies and Procedures. After an investigation into this complaint, including review of the Inspector's notes and enforcement documents, the complaint was found to be unsubstantiated.
Complaint	A complaint was received from a POI regarding an inspector issuing them with fines relating to inadequate veterinary treatment.
Outcome	After speaking with the inspector, and observing veterinary records, the complaint was found to be unsubstantiated.
Complaint	A complaint was made by a POI regarding a horse which required urgent veterinary treatment. The POI did not believe the horse needed to be euthanised on welfare grounds.
Outcome	After consultation with the Inspector and the equine vet, it was determined that the Inspector had followed all AWL NSW Policies and Procedures. The complaint was found to be unsubstantiated. .
